Town Council Election

As of issuance of this newsletter, it appears that there will be an election of Council members in September. Five candidates have filed so far to fill the four Council positions up for election. In the absence of any of those candidates dropping out, an election will be required. Other possible candidates have until July 23 to file. We intend to provide members with more information about the election and the candidates in August.

Recycle Items and Yard Waste

With the summer months and the influx of renters and visitors, a number of questions and problems have been reported regarding what should and should not be included in the recycle bins and how yard waste should be put out for collection. The requirements and restrictions are clearly set forth in sections 486-20 (Recycling) and 486-21 (Yard Waste) of the Town Code. For those with internet capability, it would be a good idea to download the provisions from the Town website to serve as a helpful reminder and guide.

For immediate use, here are a few reminders about requirements and exclusions that could be most helpful.

Recycle Preparation

- Rinse and remove food and liquids from recycle items.
- Remove caps and lids from bottles and containers and discard in regular trash NOT recycle bin.
- Cut (not fold) all cardboard into 2 x 3 foot sections and put in bin.

Recycle Exclusions

- Appliances, auto parts, batteries and electronics
- Plastic bags, packing material and plastic furniture
- Pots and pans and wire hangers
- Bottle and jar caps and lids
- Clothing and shoes
- Light bulbs and ceramics
- Styrofoam of any type (hot beverage cups, take-home food containers, egg cartons, meat trays, popcorn packing material, etc.)
- Napkins, paper plates and pizza boxes (surprisingly) and shredded paper
- Garbage (obviously)

All of these items reportedly have been thrown in recycle bins at times due to ignorance or carelessness, which adds to the time and cost of the recycle processing.

Yard Waste Preparation

- All grass clippings and leaves must be placed in recyclable paper yard waste bags (NOT plastic trash bags), or in containers 32 gallons or less that are clearly marked as yard waste. Filled bags and containers shall not weigh more than 50 pounds.
- Brush and limbs should be no longer than five feet and bundled (tied) and separated into piles small and light enough for one individual to handle. Tree limbs and logs should be no larger than four inches in diameter.

Yard Waste Exclusions

- Tree stumps
- Treated lumber and wood
- Dirt and rocks

Complete information is set forth in the Town Code provisions.

Farmers' Market Needs New Board Members

Volunteers are needed to serve on the board of the Farmers' Market due to a number of long-time board members leaving because of retirement, health reasons and moving out of the area. The Board deals with "preseason" planning for the Market, including such areas as: market policy, advertising, budgets, outreach, website, insurance, organization of onsite contractor and/or volunteers, and liaison with Town staff. Some Board members also volunteer at the Market on Sunday mornings.

The Bethany Beach Farmers' Market, Inc. was incorporated by several Bethany Beach citizens in 2007 as a Delaware nonprofit organization. It has been supported by BBLA and the Town since its start. The market is widely regarded as a benefit to the community and has been one of the most successful "Sell-What-You-Grow" markets in Delaware. The 16 local farmer participants need citizen support and volunteers for it to continue to operate as successfully as it has.
