## AMENDMENTS TO ARTICLES VIII (OFFICERS) AND XIV (BOARD OF DIRECTORS)

## ARTICLE VIII—OFFICERS

Section 2. Nominations for election to fill Officer positions shall be presented by the Nominating Committee to the members participating in an Annual Meeting. Nominations from members also may be presented, provided that such nominations are submitted to the Nominating Committee at least thirty days before the Annual Meeting, together with a resume and written commitment by the nominee confirming that he or she is willing to serve if elected.

## ARTICLE XIV—BOARD OF DIRECTORS

Section 1a. The Board of Directors shall consist of not less than nine nor more than sixteen members of the Association, to include the President, who shall be ex-officio Chairman of the Board, the Vice President, Treasurer, the Recording Secretary and Membership Secretary.

1b. Directors shall be elected by a majority of members participating and voting at an Annual Meeting. Nominations for election shall be considered and presented to the members by the Nominating Committee. Nominations from members also may be presented, provided that such nominations are submitted to the Nominating Committee at least thirty days before the Annual Meeting, together with a resume and written commitment from the nominee that he or she is willing to serve if elected.

1c. Each member of the Board shall serve for a term of two years, unless appointed by the President to serve for a temporary period, in accordance with Article IX, Section 3 of the Bylaws. The terms of the Directors are staggered, and only the number of Director positions with expiring terms, or otherwise vacant shall be open for election at each Annual Meeting.

## ARTICLE VIII—OFFICERS

Nominations for election shall be considered and presented to the members by the Nominating Committee.
